



**Pappy's Canoe Rental & Shuttle Service  
Notification of Risks (NOR)**

In consideration of the services of Pappy's Canoe Rental & Shuttle Service and their officers, agents, employees, and stockholders, and all other persons or entities associated with those businesses (hereinafter collectively referred to as ("Pappy's Canoe Rental & Shuttle Service") I agree as follows:

Although Pappy's Canoe Rental & Shuttle Service has taken reasonable steps to provide me with appropriate equipment and skilled guide's so I can enjoy an activity for which I may not be skilled, Pappy's Canoe Rental & Shuttle Service has informed me this activity is not without risk. Certain risks are inherent in each activity and cannot be eliminated without destroying the unique character of the activity. These inherent risks are some of the same elements that contribute to the unique character of this activity and can be the cause of loss or damage to my equipment, or accidental injury, illness, or in extreme cases, permanent trauma or death. Pappy's Canoe Rental & Shuttle Service does not want to frighten me or reduce my enthusiasm for this activity, but believes it is important for me to know in advance what to expect and to be informed of the inherent risks. The following describes some, but not all, of those risks.

**Description of Risks:** Including, but not limited to: drowning; cuts or abrasions due to unforeseen sharp objects in the landings, riverbed, campsites or parking areas associated with Pappy's Canoe Rental & Shuttle Service or the National Park Service; sun-burn; insect or wild-animal bite; Lyme's Disease associated with tick bite; burns from improperly constructed or maintained fires associated with camping and/or food preparation; personal injury due to reckless or careless use of wood cutting or wood chopping tools; and any other irresponsible activity. Risk is further extended to include any personal injury or death, associated with the over indulgence of, or irresponsible use of, alcoholic beverages or other illegal or controlled substances, while utilizing the river-way.

I am aware that Pappy's Canoe Rental & Shuttle Service entails risks of injury or death to any participant. I understand the description of these inherent risks is not complete and that other unknown or unanticipated inherent risks may result in injury or death. I agree to assume and accept full responsibility for the inherent risks identified herein and those inherent risks not specifically identified. My participation in this activity is purely voluntary, no one is forcing me to participate, and I elect to participate in spite of and with full knowledge of the inherent risks. I have been provided a minimum of one (1) Coast Guard approved Personal Flotation Device (PFD) of the proper size. I further acknowledge that all minor children under my care at or below the age of 13 are required to wear a properly fitted, serviceable PFD at all times when the vessel (canoes, boats, inner tubes, kayaks, etc) is in motion.

I acknowledge that engaging in this activity may require a degree of skill and knowledge different than other activities and that I have responsibilities as a participant. I acknowledge that the staff of Pappy's Canoe Rental & Shuttle Service has been available to more fully explain to me the nature and physical demands of this activity and the inherent risks, hazards, and dangers associated with this activity.

I certify that I am fully capable of participating in this activity. Therefore, I assume and accept full responsibility for myself, including all minor children in my care, custody, and control, for bodily injury, death or loss of personal property and expenses as a result of those inherent risks and dangers identified herein and those inherent risks and dangers not specifically identified, and as a result of my negligence in participating in this activity.

I have carefully read, clearly understood and accepted the terms and conditions stated herein and acknowledge that this agreement shall be effective and binding upon myself, my heirs, assigns, personal representative and estate and for all members of my family, including minor children.
